Hayes County Commissioners Regular Meeting January 10, 2017

The Regular meeting of the Hayes County Board of Commissioners was scheduled for Tuesday, January 10, 2017 at 8:30 A.M. in the Courthouse in Hayes Center, Nebraska. Advanced notice of the meeting, time and place was given by publication and posted in accordance with law. Those present were Wayne Christner, Barry Richards, Jeffrey Unger, Rita Erickson, Susan Messersmith, Craig Softley, Boyd Gigax, Phil Dixon, D. Eugene Garner, Leon Kolbet, Tom Dow, Joe Miller and Mark Clifford. Visitors were Christina Berry and Greg Rasmussen.

Vice Chairman Christner opened the meeting at 8:35 A.M. Roll call: Christner, present; Unger, present; Richards, present.

The floor was opened for nominations for Board Chair for calendar year 2017. Christner nominated Unger. The nomination was seconded by Richards. There were no further nominations and nominations ceased. Roll call vote was taken on the nomination of Unger as Chair for the calendar year 2017. Richards, yes; Christner, yes; Unger, abstain. Motion carried.

The floor was opened for nominations for Vice Chair for calendar year 2017. Richards nominated Christner. The nomination was seconded by Unger. Dixon informed the Board the joint application of Hayes/Hitchcock Counties bridge management projects has been accepted. The county is still waiting for final delivery of all posts to proceed with the chevron sign project.
