Hayes County Commissioners Regular Meeting February 14, 2017

The Regular meeting of the Hayes County Board of Commissioners was scheduled for February 14, 2017 at 8:30 A.M. in the Courthouse in Hayes Center, Nebraska. Advanced notice of the meeting, time and place was given by publication and posted in accordance with law. Those present were Wayne Christner, Barry Richards, Jeffrey Unger, Rita Erickson, Susan Messersmith, Craig Softley, Phil Dixon, D. Eugene Garner, Nancy Frecks and Kimberly Cook. Visitors were Tyler Thiessen.

Chairman Unger opened the meeting at 8:40 A.M. Roll call: Christner, present; Unger, present; Richards, present.

Motion by Richards, second by Christner to approve the agenda. Roll call vote: Unger, yes; Richards, yes; Christner, yes. Motion carried.

In accordance with Section 84-1412 of the Nebraska Revised Statutes, Unger announced that a current copy of the Open Meetings Act is available for review and is posted on the wall of the Commissioner Room.

Chairman Unger requested comments from the audience. There were none.

Craig Softley, Hayes County Economic Development Coordinator, gave an update on the recent community meetings. From those meetings, a list of priorities have been established. Available housing tops the list of needs.

Char Hamilton, Emergency Manager, discussed road signs and paper work with the Commissioners.
