Hayes County Commissioners
November 10, 2020

A meeting of the Hayes County Board of Commissioners was scheduled for November 10, 2020 at 8:30 A.M. in the Courthouse in Hayes Center, Nebraska. Advanced notice of the meeting, time and place was given to each Commissioner, was published in the *Times Republican* on November 5, 2020, and posted in accordance with law. Chairman Unger called the meeting to order at 8:39 A.M. The Open Meetings Act was available for review and Chair indicated location of such copy in the room where the meeting was being held. Those present were Wayne Christner, Barry Richards, Jeffrey Unger, Rita Erickson, Susan Messersmith, D. Eugene Garner and Curtis Smith.

Richards moved, second by Christner to approve the agenda. Roll call vote: Unger, yes; Richards, yes; Christner, yes. Motion carried.

There were no comments from the public.

Richards moved, second by Unger to approve the consent agenda consisting of financial reports of the Clerk, Clerk of the District Court, Imprest Account, and the minutes of the October 13, 2020 meeting. Roll call vote: Richards, yes; Christner, yes; Unger, yes. Motion carried.

Christner moved, second by Richards to adopt Resolution 2020-12, Year-end Certification of County Highway Superintendent for 2020. Roll call vote: Christner, yes; Unger, yes; Richards, yes. Motion carried.

Unger moved, second by Christner to adopt Resolution 2020-13, NIRMA/NIRMA II Intergovernmental/Interlocal Agreements. Roll call vote: Unger, yes; Richards, yes; Christner, yes. Motion carried.

Curtis Smith, with Wellness Partners, joined the meeting to discuss health insurance plans for the upcoming year.

Unger moved, second by Richards to approve the re-insurance contract and appoint the Hayes County Clerk as authorized signer. Roll call vote: Richards, yes; Christner, yes; Unger, yes. Motion carried.

Unger moved, second by Christner to designate Hayes County Sheriff's Office as the animal control authority for Hayes County. Roll call vote: Christner, yes; Unger, yes; Richards, yes. Motion carried.

Richards moved, second by Christner to approve the Treasurers Report. Roll call vote: Unger, yes; Richards, yes; Christner, yes. Motion carried. Motion carried.

Unger moved, second by Richards to approve payroll for \$79,460.96. Roll call vote: Richards, yes; Christner, yes; Unger, yes. Motion carried.

Richards moved, second by Christner to approve claims, excluding claim 2011060, for \$53,002.43. Roll call vote: Christner, yes; Unger, yes; Richards, yes. Motion carried.

Unger moved, second by Christner to approve claim 2011060 for \$9,715.50. Roll call vote: Unger, yes; Richards, abstain; Christner, yes. Motion carried.

Chairman Unger adjourned the meeting at 11:25 A.M.
