## Hayes County Commissioners January 14, 2025

A meeting of the Hayes County Board of Commissioners was scheduled for January 14, 2025, at 8:30 A.M. in the Hayes County Courthouse, 505 Troth Street, Hayes Center, Nebraska. Advanced notice of the meeting, time and place was given to each Commissioner, was published in the *McCook Gazette* on January 10, 2025, and posted in accordance with law. A current copy of the Open Meetings Act was available for review and was posted in the room where the meeting was being held. All proceedings shown hereafter were taken while the convened meeting was open to the attendance of the public.

Vice-Chairman Christner called the meeting to order at 8:30 A.M. Those present were board members: Wayne Christner, Barry Richards, and Kevin Fornoff; Tammy Schwenk, County Treasurer; Susan Messersmith, County Clerk; D. Eugene Garner, County Attorney; Marian Richards, Sign Tech and Joe Miller, Emergency Manager.

Richards moved, second by Christner to amend the agenda to include payroll. Discussion held. Roll call: Richards, yes; Christner, yes; Fornoff, yes. Motion carried.

Christner moved, second by Richards to approve the consent agenda consisting of the financial reports of the Clerk, Clerk of the District Court, Imprest Account and the minutes of December 10 & 30, 2024 meetings. Fornoff moved, second by Richards to adopt Resolution 2025-2, designation of The Hayes Center Times Republican and/or the McCook Gazette as official newspapers of publication for Hayes County for 2025 and to designate the County's website, <a href="http://www.hayescounty.ne.gov">http://www.hayescounty.ne.gov</a> as an additional method of providing notices. Richards moved, second by Fornoff to adopt Resolution 2025-3, authorization for Hayes County Treasurer to invest monies. Discussion held. Roll call: Richards, yes; Christner, yes; Fornoff, yes. Motion carried.

Fornoff moved, second by Richards to adopt Resolution 2025-4, authorization for Hayes County Treasurer to transfer monies. Discussion held. Roll call vote: Christner, yes; Fornoff, yes; Richards, yes. Motion carried.

Fornoff moved, second by Christner to adopt Resolution 2025-5, authorization for Hayes County Treasurer to have funds secured with a pledge receipt. Roll call: Fornoff, yes; Richards, yes; Christner, yes. Motion carried.

Christner moved, second by Richards to designate the second Tuesday and last business day of each month as regular meeting dates. Discussion held. Roll call: Richards, yes; Christner, yes; Fornoff, yes. Motion carried.

Fornoff moved, second by Richards to direct Chairman to sign the one-year audit engagement letter for fiscal year ending June 30, 2025, with Donald D. Wilson, CPA, for \$8,400.00. Discussion held. Roll call: Fornoff, yes; Richards, yes; Christner, yes. Motion carried.

Christner moved, seconded by Fornoff to adjourn the meeting. There being no further discussion. Roll call: Richards, yes; Christner, yes; Fornoff, yes. Motion carried.
